Svensson E. **Analysis of systematic and random differences between paired ordinal categorical data.** Thesis, Göteborg University, Göteborg, 1993.

- Development of rating scales and questionnaires
- Developed statistical methods for identification and evaluation of systematic disagreement/change in paired ordinal data separately from additional individual variability for quality evaluation of scale assessments and for evaluation of change in paired scale assessments.
- The measures of relative position (RP) and of relative concentration (RC) express the levels of systematic disagreement/change in position and concentration of paired assessments on the scale, respectively. The measures of relative rank variance (RV) and of disorder (D) express presence of additional individual variability in paired assessments.
